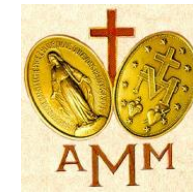


Association of the Miraculous Medal



The Association of the Miraculous Medal is an apostolate of the Congregation of the Mission and the Daughters of Charity.

The History of the Association

The Association of the Miraculous Medal (AMM) came to birth soon after the appearances of the Virgin Mary to St. Catherine Labouré, a Daughter of Charity, in the Mother House of the Daughters of Charity at 140 Rue du Bac Paris in 1830.

On Mary's second appearance to St. Catherine on 27th November that same year Catherine was entrusted with a message "Have a medal struck, and those who wear it with confidence will receive great graces".

Catherine confided her message to her confessor who, after much hesitation and deliberation, approached the Archbishop of Paris who responded "Go ahead with it and please give me the first one"

The first medals were made in June 1832. The propagation of the medals was prodigious, the demand exceeding the supply. There were amazing graces, conversions, cures and miracles, and the medal was popularly called "The Miraculous Medal."

On 8th July 1909, the Statutes of the Association were approved and confirmed officially by Pope Pius X.

The Association spread rapidly through many countries of the world, and in 1998 the International Statutes were reviewed and approved.

Membership of the Association.

Millions of people who wear the Miraculous Medal form the Association.

The Association is made up of general and particular members.

General members are those who wear the medal, which has been blessed, with devotion.

Particular members are members who have been invested with the medal of the Immaculate Conception, which has been blessed by a priest, and who wear it with devotion. Members offer their names to be entered on the roll of the Association.

Purpose of the Association:

- To honour Mary conceived without sin.
- To assist the faith development of its members
- To render some form of service to those in need. "to bring good news to the poor and set free the oppressed."

Mary's medal, both by the symbolism which it shows and by the power it enjoys, offers both a model and assistance for those purposes.

Spiritual Benefits of the Association:

The Church has granted indulgences to the members from 1995 on the

- Day of investiture
- Feast of the Queenship of Mary (August 22)
- Feast of Our Lady of the Immaculate Medal (Nov.27)
- Feast of St. Catherine Labouré (Nov.28)

Liturgical feast of the Association is 27th November
